

Form of Extended Warranty

WHEREAS purchaser has purchased and paid for an extended 18-month warranty ("The Extended Warranty") for the Covered Vehicle; and

WHEREAS the Covered Vehicle is herein defined as a Miles ZX40 or Miles ZX40s bearing VIN# _____

WHEREAS the Covered Vehicle is warranted under an 18-month limited warranty ("The Original Warranty"); and

WHEREAS the Extended Warranty is to come into effect immediately upon the expiration date of the Original Warranty,

NOW THEREFORE, Miles Automotive Group, Ltd covenants and agrees as follows:

1- The within Extended Warranty was purchased on _____, 20__ by _____ of _____ (Address) and covers a Miles ZX40 or Miles ZX40s vehicle bearing the VIN _____.

2- The Extended Warranty shall continue in full force and effect, covering the Vehicle described above ("the Covered Vehicle") for a period of 18-months, commencing on _____, 20__ and continuing for 18-months thereafter.

3- The Extended Warranty shall provide for a limited warranty for the Covered Vehicle to the same force and effect as the Original Warranty, all as set forth, described, and limited in paragraphs 1 through 8 inclusive of the Original Warranty with the following exceptions only:

Batteries and tires are covered solely by the original warranty and by any additional battery and/or tire warranty issued to the Purchaser at the time that any new batteries and/or new tires are purchased for the Covered Vehicle. It is understood that any such replacement batteries and tires will be covered by the warranty terms and conditions in effect and covering such replacements at the time of replacement.

Scope & Limitation of Warranty

Miles Automotive Group, Ltd. makes no warranty of any kind express or implied which exceeds the warranty or time limits expressly stated herein and no representation or agreements to the contrary by any person may vary or alter the terms of this warranty. Our only liability under this warranty is limited to the repair and replacement described herein, and Miles Automotive Group, Ltd. shall not be held liable for any implied warranty or incidental or consequential damages including loss to person or property and loss of use of the vehicle.

How to Obtain Service

- Warranty service can be obtained from your local authorized Miles Automotive Group Dealer which may be the Dealer from whom you purchased your vehicle, or from a Company Authorized Service Provider.
- Fleet and other multiple vehicle owners can elect to have warranty repairs and remediation performed by their own or designated mechanics who have been certified by the Company to perform warranty services.
- Warranty parts and prior approval of warranty service can be obtained by contacting the company in the manner set forth under "Making a Warranty Claim" below.

Transfer of Warranty

Upon the sale or transfer of the Covered Vehicle, you or the subsequent owner may for a fee of \$50.00 transfer this Extended Warranty in accordance with Company procedures, but nothing shall serve to extend the period of this Extended Warranty beyond its 18-month term.

Validity

This Extended Warranty is valid only when paid for and issued at the same time that the Covered Vehicle was purchased and only if subscribed below by Miles Automotive Group, Ltd.
